



ARTICLES OF INCORPORATION OF THE  
**NAPA VALLEY PERSONAL COMPUTER USERS GROUP**  
A CALIFORNIA PUBLIC BENEFIT CORPORATION

**Article One.** The name of this corporation is the **Napa Valley Personal Computer Users Group.**

**Article Two.** This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes. The specific purposes for which this corporation is organized are to **provide a forum in the Napa Valley community to educate by acquiring, promoting, exchanging, and disseminating knowledge, ideas, and information to the general public about personal computers (hardware and software) and their uses; and to provide education and help in solving computer related problems; and to educate and foster the development of computer related skills among members and the general public.**

**Article Three.** The name and address in the State of California of this corporation's initial agent for service of process is:

**Article Four.**

- (a) This corporation is organized and operated exclusively for educational and charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.
- (b) Notwithstanding any other provision of these Articles, this corporation shall not carry on any other business activities except those specifically authorized by California corporation law.
- (c) No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation.

The corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of, or in opposition to, any candidate for public office.
